Consignment Fees:

- **30%** of the sale price of any item that sells in our Shop, our satellite spaces, or at one of our Antiques Barn Sales
- **40%** of the selling price of any item on EBay (includes all fees, shipping, etc.)

Please specify your 'Bottom Line' (BL) price. Your BL is the lowest price you will accept for your item after our fee deductions. If we think your BL is too high or if the item is not appropriate for our shop or online sales, Old Road Antiques will not accept the item.

30/60/90/120 Timeline: (*does not apply to items consigned on EBay)

This timeline is for your and our protection. Please contact us if your needs require an exception. We want to be flexible, but also to avoid misunderstandings. Staying aware of your item's progress is important.

- After **30** days, any unsold item may be reduced in price by **20%**, regardless of the stated Bottom Line. If your item is here during one of our Sales, it may likewise be reduced in price by **20%**, unless you request that it not be part of the sale.
- After **60** days, any unsold or un-reclaimed items may be removed from display.
- After **90** days, un-reclaimed items may be taken to a local auction house. For this service, we charge 20% of sale price. The auctioneer will take an additional 20-30% of sale price.
- After **120** days, un-reclaimed items become the sole property of Old Road Antiques.

Other policies:

- We will pay our consignors by check after the 60-day period has expired, or earlier if you come in person to collect.
- Old Road Antiques LLC, Sarah Hirsch, and/or Geoffrey Hirsch shall **not** be liable for loss or injury due to theft, accident, breakage, fire, water, or any other cause whatsoever. The consignor agrees to provide insurance for such loss. The above named are expressly released from any and all liabilities from any loss, injury, or damage to persons or property. This agreement specifically includes all goods/merchandise on any premises supervised by the above named. The consignor assumes full responsibility for injuries to him/herself, agents, or property and will indemnify owners named above against any claim for any such injury or harm.
